PROFILE

SallyAnne has over twenty years of experience working in the private, voluntary and local government sector on community related projects ranging from education work for large scale corporates (corporate social responsibility), to a national youth charity and local government. Since May 2023 she has been a senior associate working mainly for Community Stewardship Solutions (CSS).

For CSS, SallyAnne is currently leading on stewardship at Gilston Park for Places for People and supporting work at Letchworth City Trust amongst other projects, acting for developers and councils. For Design South East, she is a member of the Design Review Panel for Hemel Garden Communities and also providing additional support on stewardship to the Hemel Garden Town Team.

At Otterpool Park, SallyAnne has supported S106 negotiations for stewardship and community development and is currently drafting the stewardship vehicle business plan. She has been a Non-Exec Director since 2020 on the Board of the LLP.

At Ashford BC, SallyAnne led the team who orchestrated and negotiated the creation of a stewardship body for Chilmington Green (5,750 dwellings), part of South of Ashford Garden Community (SAGC) from S106 negotiation, outline planning permission and master planning to delivery. She helped secure over £24m in community assets. From 2016 to 2023, she also coordinated the Chilmington project strategically on behalf of Ashford Borough Council and delivery partners, ensuring council resources were in place to maximize the pace of housing delivery, manage risk and to support the development and implementation of an appropriate governance and programme management structure. She led the coordination of the wider SAGC (7,250 dwellings) and was instrumental in securing 'Garden Village' status from MHCLG in 2019 and secured over £750k to support early delivery.

SallyAnne played a key role in the development of the first business plan for the Chilmington Management Organisation (CMO), managing the transition from Board precursor to 'go live', working across strategic partners including developers, to ensure a fit for purpose, robust model of delivery was created. She co-wrote the first community development strategy and successfully brought the CMO to fruition. She has valuable first hand insight to the set up and leadership required for new build stewardship organisations.

Her most recent appointment is as Independent Chair for Leybourne Grange CIC, where she is also supporting the organisation's operations on an interim basis. A key role here is developing the governance arrangements and board to ensure resilience and compliance.

In 2019, SallyAnne was part of a Regen Co Team working with Homes England to produce a stewardship toolkit for Homes England's own large scale sites. SallyAnne is a regular speaker on stewardship at TCPA events and as part of the Homes England Garden Communities Programme.
